3. Deadline & Food Sanitation Law in Japan

<<IMPORTANT>>Tentative deadline of forwarding required documents

For Advanced Document-survey

January 18, 2019 ----

- · Proforma Invoice
- · Ingredient List
- · Additive List
- Manufacturing Process Chart

The above four documents are indispensable for document-survey. We are considering to survey the documents internally for two weeks. Eventually we shall be able to advise which items are to be examined, or which items have a potential to be ordered of testing by MHLW, which items can be processed for Formal Food Import Notification.

I [For tasting, Give away, Retail]

⇒Apply for "Food Import Application" to MHLW ETA NRT No later than February 5(tue) 2019

Food products will be used for retails or tasting, give away, Importers (Exhibitors) must apply for "Food Import Application" which needs be submitted to MHLW(the Ministry of Health, Labour and Welfare), even though exhibition.

When submitting "Food Import Application", importers (Exhibitors) must show the evidences that each food is safe and legal under Food Sanitation Law in Japan, with ingredient list and manufacturing processing chart sheet.

Also importers(Exhibitors) must show the evidence required, follow the orders, answer the questions for items from inspector of MHLW, and some products must be inspected by authorized laboratory and

required inspection. (The inspection charge is those who import it load.)

Approval to import will be made after the result of the inspection.

(The inspection would take about 3 weeks and need \(\frac{4}{20}\),000-\(\simeq\)\(\frac{4}{60}\),000-\(\simeq\) product.)

II (Only use for Display (No tasting, No giving away, No retail)] ⇒Apply for "Confirmation Request" to MHLW ETA NRT No later than February 14(thu) 2019

In case the food will be used only for display, apply for "Confirmation Request" to MHLW instead of "Food Import Application". Should Exhibitors wish to import by "Confirmation Request", a signature on attached "Certificate for exhibition goods" is required.



4. NOTIFICATION of SPECIFIC ITEM

To whom it may concern

Thank you for your attention to FOODEX JAPAN 2019.

Most of the products for this exhibition are subject to "Food Sanitation Law" in Japan, and exhibitors must follow this law.

In order to minimize risks and avoid troubles, we would like to ask for you and exhibitors' cooperation.

Please note that only the food products approved by MHLW (Ministry of Health, Labor and Welfare) could be used for tasting and give-away at FOODEX site.

Based on our experiences in the past, we listed major points for your review. Please make sure to follow the instructions below.

WINE

- 1) Make sure to indicate alcohol percentage (%) and volume(ml) on invoice.
- 2) For tasting or give-away, Certificate of Analysis of each wine, which shows amounts of <u>Total SO2</u> and <u>Sorbic Acid</u> is required.

EXTRA VIRGIN OLIVE OIL

- 1) Pure Ex virgin olive oil is easy to get approval "Food Import Application". Duty is Free.
- 2) If Olive oil contains other ingredient (for example, herb), it is not easy to get approval "Food Import Application". Duty is 21.3%.

• MEAT ,MEAT PRODUCTS and All Cheese(Natural Cheese and Process cheese)

- Do not combine with other suppliers products.
 AWB must be issued each supplier basis.
- 2) "Health Certificate" is required.
- 3) It is impossible to import any meat and meat products which is not listed on "Health Certificate".
- 4) It is very difficult for meat and meat product to get the approval for tasting, give-away and retails. If necessary, it takes about 3weeks and standard inspection fee will be JPY 50,000-product.

• FRESH FRUITS & FRESH VEGETABLES

"Phytosanitary Certificate" is required.

Some fresh fruits & fresh vegetables are prohibited to import.

So please let us know the botanical names to check in advance when you get an inquiry from shipper.

FROZEN FOOD

- Please issue back to back (1 HAWB & 1 MAWB) for frozen foods.
 Do not issues single (Carriers) AWB.
- 2) You must indicate required temperature on both HAWB and MAWB.

 Freezer at Narita can not be set lower than -10C. So if the storage temperature needs to be colder than -10C, you must notify us in advance and make sure "RE-ICE WITH DRY ICE" on the AWB handling information.

It is very difficult for frozen food to get the approval for tasting, give-away and retails. If necessary, it takes about 3weeks & more and standard inspection fee will be JPY 50,000- per item.

SOFT DRINK (no object liquid or powder)

It is very difficult for soft drink to get the approval for tasting, give-away and retails. If necessary, it takes about 3weeks and standard inspection fee will be JPY 60,000- per product.

• FOOD PRODUCT using vanilla and vanilla flavour

Wild Vanilla is one of the species internationally protected by CITES. If artificial cultivated vanilla is used, please advise exhibitor to mention it on the invoice, not on ingredients list.

If not, we can not clear the customs.

(Example sentence: The vanilla used for this product is artificially cultivated and not wild.)

GRAINS

(Such as; rice, wheat, barley, buckwheat, millet, canary seeds etc.)

Please make it arrival at Narita no later than Feb 6th.

IMPORT QUOTA OF SEAFOOD (FRESH, FROZEN, SALTED, DRIED)

Exhibitor must get import quota certificate of following sea food by themselves. (we could not support for this procedures)

Fish: Herring, Cod, Yellow-tail, Sardine, Saury, Mackerel, Horse Mackerel, Scallop, Adductor, Squid (excluding Common cuttlefish), Seaweed, Kelp, Cod roe

• FRESH, FROZEN FISH & PROCESSED FISH

There are some marine products internationally protected by CITES. So please let us know the scientific names in advance when you get an inquiry from shipper.

CAVIAR

Sturgeon is one of the species internationally protected by CITES.

Whether Sturgeon is wild or firm-raised, Caviar could not be imported without CITES permission.

• **SUGAR**

Exhibitor must apply for permission to import sugar by themselves and we could not support for this procedures.

Please advise Exhibitors not to send sugar.

DAIRY PRODUCTS (except cheese and yogurt)

Exhibitor has to apply for permission to import dairy products by themselves and we could not support for this procedures.

Please advise Exhibitors not to send dairy products.

We will appreciate for your understanding and support.
